The unit owners of the Villas of Kings Crossing approved the amendment change by a majority vote of twenty-three (23) for and five (5) against. The amendment change is in effect as of May 14, 2009 and has been approved by the Board of Directors.

Amended Change: All prospective lessees must submit an application for lease provided by the Board of Directors and gain lease approval from the Board of Directors prior to unit owner granting prospective lessee occupancy. The lease of any unit shall not be for a term less than six (6) months.

Current and future considerations for an individual unit lease will require that the prospective lessee obtain an application for lease from Accurate Accounting, located at 100 Sullivan Street, Suite 112, Punta Gorda, FL 33950. When the application has been completed, it will then be returned to Accurate Accounting for Board of Directors review.
